




St. John's College was founded in 1887 by Father Cassian Gillett (Jesuit) as a school for boys. SJC was first located at the Catholic Presbytery, Holy Redeemer Cathedral, in Belize City.

On July 17, 1917, the faculty and students moved to the campus known as the Loyola Park. In 1931 on September 11, Belize experienced a catastrophic Hurricane (Hattie) in which 11 Jesuits died and the campus was destroyed. The destruction of the campus required the school's return to the cathedral temporarily.

In 1952 St. John's College finally moved to its new and current campus named after



the Central American poet and renowned scholar, Rafael Landivar, S.J. In early 1952, in response to the

growing need in Belize for higher levels of academic training, St. John's College expanded its traditional fouryear high school program, offering a limited number of post-secondary school courses under the direction of Father Robert Raszkowski, S.J. Over time, these limited offerings expanded into what, in the British tradition, is called Sixth Form, a two-year program leading to Advanced Level Examinations, or simply, the "A-Levels." These external examinations are set by Cambridge University.

In the mid-1960's, SJC broadened the program of studies so that it met the requirements of the Associate Degree awarded by junior and community colleges in the United States. This provided graduates of St. John's College Sixth Form a choice of further studies: they could enter Commonwealth Universities which Level" require Cambridge "Δ certificates or Unites States Universities as transfer students into the third year of an undergraduate degree program. In 1960, St. John's College Sixth Form was granted membership in the American Association of Community and Junior Colleges.

## PAYMENT GUIDELINES

### **PAYMENT PROCEDURES**

The College policy on tuition and fee payment requires that registration for classes be finalized only after ALL tuition is paid. You are therefore reminded that registration is not complete until ALL tuition is paid. This requirement and the accompanying procedures are explained below.

During registration, the Finance Office, through the Office of the Registrar, will issue you an SJC pro forma invoice for payment. Payment for registration must be made at any branch of Atlantic Bank or Belize Bank countrywide. When paying, you must present the SJC pro forma invoice to the bank teller. The teller will record all this bank information for proper processing of your payment. Please ensure that the receipt you obtain from the bank has your ID number and name, as reflected on the pro forma invoice. You are advised to save the proforma invoice and bank receipt of payments for your record keeping.

If you do not make payment within specified time frame. the vour registration will be canceled. When your registration is canceled, the space reserved for you in the particular classes you had registered are made available to other students. Once you completed registration have the process (registering and finalizing of full payment of tuition and fees), your name will be placed on the official class list. If your name does not appear on the official class list, you will not be allowed to enter the specific class.

If you are a returning student with arrears, you will be blocked from registering until full payment of ALL arrears is made. Once arrears are paid, you may then proceed with registration for the new semester and must pay ALL current tuition and fees.

The pro-forma invoice issued at registration is a preliminary invoice. Any adjustments to your bill for any changes made during the drop/add period will be made forthwith, and a new pro-forma invoice will be issued for the adjusted balance. You may at any time request a statement from the Finance Office.

If you (and your parents, if they are responsible for your tuition and fees) need to make arrangements for payment as allowed through the college payment plan system, you must make these arrangements with the finance officer within the time frame set by the Finance Office. Students applying for financial aid need to do so before the registration process begins.

### PAYMENT PLANS

The payment plan is rendered to students who are unable to meet full payment at the time of registration. This agreement is made personally between parent/guardian and the Finance Office. Students who pay their own tuition and fees are required to submit a letter from the parent/guardian confirming this.

Notwithstanding that you have selected a payment plan, you may pay the full amount of your outstanding balance at anytime. Students are able

to undertake payments in two, three, or five equal payments. There is no payment plan agreement for summer sessions.

### **TUITION & FEES AND REGISTRATION**

Please note that registration is not considered complete until students have paid full tuition and fees.

Full tuition and fees, or the first installment on the payment plan, must be made no later than the posted dates. Students who do not pay full tuition and fees or make appropriate arrangements by the dates indicated will have their registration cancelled and will be blocked from registration, as well as receipt transcripts of grades, of diplomas, letters copies of recommendations, or credit at the bookstore. This information can also be found on the Admissions page of the school's website.

### **TUITION ASSISTANCE & REIMBURSEMENT**

Students whose employers, the Government of Belize, or any other sponsoring organizations have made arrangements with St. John's College's Finance Office to pay tuition and fees or cost of books should bring a signed letter of commitment from the sponsor to the Finance Office no later than five business days after registration. If the sponsor's commitment does not provide for full payment, the student is required to appropriately settle the balance ( either by paying the balance or using the payment plan system). All students who receive a scholarship after having paid at the time of registration will be reimbursed upon graduating.

Students who withdraw from classes no later than the last day of the official drop/add period set by the Office of the Registrar will receive a refund of full tuition and fees. Students who officially withdraw from classes within the first three weeks of the semester are refunded 1/3 tuition only. No refunds are made after this time.

### FINANCIAL AID & SCHOLARSHIPS

Students receiving financial assistance from SJC must consult with the Associate Dean for Student Affairs to verify their financial assistance package. Students must have a current, approved SJC Financial Aid commitment or scholarship on file at the time of registration before any financial assistance can be applied to the payment of tuition and fees.

Students in their first year who passed three or more of the CSEC examinations, including English A and Mathematics, and are Belizeans by birth or nationality, must submit a copy of their CSEC results along with their social security card at the Finance Office to receive a tuition scholarship from the Government of Belize. To maintain the scholarship, students must earn a G.P.A of 2.5 or higher per semester. Students are responsible for all other fees and cost of books.

The Government of Belize provides tuition scholarships for students in their second year at the Junior College, as long as they achieve a successful pass in their first semester and a G.P.A of 2.5 or above in their second semester. The Finance Office requires that students wishing to access the tuition scholarship complete a Second Year tuition form provided by the Finance Office.

### **CXC SCHOLARSHIP INFORMATION**

Students who are awarded CXC scholarships must submit a copy of their CSEC results to the Finance Office no later than September 15, 2024 in order for the Ministry of Education to be billed on their behalf. Payments already made will be credited to these students' accounts once the corresponding payments have been received from the Government of Belize. Students must maintain a G.P.A of 2.50 or above to continue to enjoy this assistance.

### LANDIVAR SCHOLARSHIP INFORMATION

St. John's College Junior College offers financial assistance through Landivar Scholarships to make tertiary education available to gualified young men and women in Belize. Application forms for this scholarship are available from the Student Affairs Office or on the school's website. Students must apply for the scholarship each in which assistance is semester for The deadline the sought. application is June 24th, 2024.

### **COLLEGE TERMINOLOGY**

### **ACADEMIC PROBATION**

When a student earns below a 2.00 GPA in any semester, he/she is placed on academic probation. This means that the student must sign a contract and improve his/her grades to be able to continue at the College. Students on academic probation are given fewer courses until their grades improve and are not allowed to withdraw without the approval of the Dean. After any 2 semesters on academic probation (including summer, if enrolled), a student may be dismissed from the college.

### **CREDIT HOURS**

This is the number of hours per week that a student meets for a course or program. Most students will take six courses every semester, and most courses meet for three hours per week. The average student is in class eighteen hours per week. This means that students have a lot of "free time"; encourage them to use this time wisely.

### HONORS

Students who earn a GPA of 3.00 to 3.49 are placed on Honor Roll. Students who earn a GPA of 3.50 to 4.00 are placed on the Dean's List. Both groups of students are honored at assemblies and at graduation.

### SJC CONNECT

St. John's College utilizes an online platform, sjcconnect.sjc.edu.bz, that serves as a course management and communication medium among instructors, students, and parents. Students are advised to note that this online portal is also the college's official grade management system.

### **COURSE PLACEMENT**

An incoming student may be required to take one or more remedial courses, such as MTH 100/101, CHE 100/101, or ENG 100/101. Such students may subsequently require an additional semester or summer session to complete his/her program.

### **ACADEMIC ADVISING**

Academic advising at the Junior College is intended to provide ongoing help in the transition from secondary to tertiary level and to help students stay on track in the program to which they have been admitted. Students are encouraged to familiarize themselves with academic requirements and procedures. Official academic advising begins during the student orientation and registration period. Mid-semester and end of semester reports are distributed via the academic advisors; this gives the advisors the opportunity to discuss academic performance and any problems students may be having.

### DROP/ADD

A student may drop or add a course without penalty on his/her academic record within the first week of the semester, known as the Drop/Add period. After this point, the student may withdraw from a course without academic penalty up until the last Thursday before the start of final examinations. Drop/Add and Withdrawal forms can be found in the Academic Bulletin or on the SJC Connect portal.





### GRADUATION

Students must apply for graduation, even when they do not plan to participate in the commencement exercises. All degree requirements must be 100% complete before the scheduled commencement exercises in order for a student to be eligible to participate and for degree conferral.

### PERSONAL DEVELOPMENT RECORD

In addition to the academic transcript, the college also records students' participation in extracurricular activities, community service, leadership positions and conduct.

### LEAVE OF ABSENCE

In adherence to institutional policy, a Leave of Absence is sought directly from the Dean in instances where a student finds it imperative to interrupt due to their academic program particular circumstances. Such leave spans no longer than two consecutive semesters, beyond which the formal readmission protocols of the college come into effect. It is imperative to note that failure to apprise the Dean of the need for a leave renders the The request ineligible. formal procedure entails the submission of a duly completed form bearing the Dean's endorsement, alongside comprehensive documentation outlining the specifics of the leave. Upon approval, the registrar procedurally withdraws the student from academic activities. Throughout the duration of the leave, the student refrains from attending classes or engaging in campus-related activities.

### **REGISTRATION PROCESS**

Registration for students accepted to St. John's College Junior College will take place in the month of June, on dates scheduled in the Academic Calendar. Each full-time student is assigned a faculty academic advisor who will assist him/her in selecting courses. Academic advisors make everv attempt to give effective guidance on course selection and academic program requirements to students and to refer them to other College resources for help in other matters. However, the final responsibilities for meeting all academic requirements and registering for the appropriate courses for a selected program rest with the student.

The registration process entitles selecting courses enrolling in those courses, and paying the relevant tuition and fees. Once courses are selected and students have signed up for a set of courses for the semester, a preliminary invoice will be issued and payments must be made at the designated bank within the time frame specified in the academic calendar. The registration process is complete only when all tuition and fees are paid.

### **GRADE POINT AVERAGE**

Grade Point Average (GPA) is a score from 0.00 to 4.00 that a student earns at the end pf each semester. It can be interpreted as follows:

- 4.00 = A
- 3.50 to 3.99 = B+
- 3.00 to 3.49 = B
- 2.50 to 2.99 = C+
- 2.00 to 2.45 = C
- 1.00 to 1.99 = D
- 0.00 to 0.99 = F





### STUDENT CODE OF CONDUCT

Any act which violates any stated student right or any tenet of the code of conduct will merit a disciplinary response. Any act that results in the violation of the national laws for which a student may be detained by the police will prompt appropriate administrative investigations. In the event that there arises ambiguity or need for clarification such interpretation or clarification will be determined at the discretion of the Dean or Associate Dean for Student Affairs.

Students are expected to display a level of professionalism indicative of an institution of higher education. This includes, but is not limited to, word choice, tone of voice, and other repertoire of expression with students, lecturers, and staff of the school.

### DRESS CODE

Students are required to adhere to the prevailing standards of good judgement in their choice of attire and are expected to conduct themselves in a way that best represents themselves and the college. Below are some guidelines:

- Dresses, skirts, and trousers must fall below the knee. Absolutely no cut up jeans for females or males is allowed.
- Shirt, blouses, and dresses must have sleeves. Strapped, strapless, halter top, low cut, tank tops, and undershirts used as outer-wear are not allowed.
- Appropriate outdoor footwear should be worn at all times. Slippers are not allowed for either male or female students.
- The student ID card is non transferable and should be visibly worn by the student at all times while on campus.

### EMAIL

Students are expected to utilize the school email address assigned to them at orientation. This will be the official means of communication for the duration of their academic experiences. It is the responsibility of the student to check their email frequently in order to stay informed of important information.

### **CLASS SCHEDULE & MODULE**

At St. John's College Junior College, classes run from 8:00 AM to 8:15 PM, designed to accommodate working individuals. Three-credit courses are scheduled either on Mondays, Wednesdays, and Fridays for 50 minutes each, or on Tuesdays and Thursdays for 75 minutes each. The standard mode of instruction is face-to-face synchronous, although there are select courses offered in an online synchronous format. The availability of adjunct lecturers determines the delivery method for these specific courses.

### **REQUIREMENTS FOR THE ASSOCIATE DEGREE**

Prospective graduates must complete all of the following requirements in order for the associate degree in their respective program to be conferred.

- 1. Pass all courses with a grade of C or above.
- 2. Achieve a cumulative Grade Point Average of 2.00 for all courses at the Junior College.
- 3. Complete at the Junior College a minimum of sixty percent (60%) of the credit hours required for the degree.
- 4. Transfer no more than a maximum of thirty (30) credit hours of study from other institutions (with approval).
- 5. Complete and submit an Application for Degree Completion by the date set on the official SJCJC Calendar.
- 6.Fulfill all financial and other obligations to the College before graduation.
- 7. Complete one hundred (100) hours of community service before the date set on the official SJCJC Calendar.
